Authorizes Land Use and Environment Group Deputy Chief Administrative Officer, Chief Sustainability Officer, and all LUEG department Directors and/or designee(s), to submit, negotiate, and execute all documents necessary for non-profit, local, state, and federal grant applications and accept grants that support the implementation of projects and programmatic activities in support of the County's vision and strategic initiatives through June 30, 2030.
2. Authorizes Land Use and Environment Group Deputy Chief Administrative Officer, Chief Sustainability Officer, and all LUEG department Directors and/or designee(s) to execute all required grant documents, including any annual extensions, amendments and/or revisions that do not materially impact or alter the services or funding levels.
