





We recommend taking the time to thoroughly evaluate several key areas within the framework: First, implementing mandatory consultations with County workers before deploying AI technologies. 2nd, ensuring that the community has a right to opt out of engaging with Generative AI systems. Third, ensuring public notification, public comment, and board vote before any data about San Diegans is shared with third parties. Furthermore, we believe it is crucial to conduct algorithmic impact assessments and provide a transparent inventory of all substantial Automated Decision Systems. We must also prioritize data privacy, limiting data collection to what is strictly necessary, and ensuring any sharing of information is clearly communicated to the public. This is by no means a comprehensive list of issues that need to be addressed with this policy, but these are crucial centerpieces.
