WHEREAS, on December 9, 2025 (11), the San Diego County Board of Supervisors adopted the 2026 Board of Supervisors regular meeting calendar in Resolution #25-130; and

WHEREAS, on May 19, 2026 (11), the Board of Supervisors amended the dates and times for meetings of the Board in June 2026 in Resolution #26-047; and

WHEREAS, it is necessary to amend the July 2026 meeting calendar to accommodate Board of Supervisors operational needs.

NOW, THEREFORE, IT IS HEREBY RESOLVED that the 2026 Board of Supervisors meeting calendar is amended as follows:

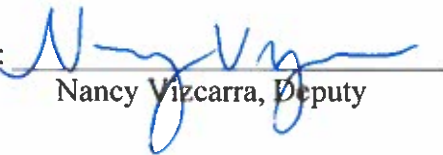
