**RESOLUTION OF THE BOARD OF SUPERVISORS ACTING AS THE
GOVERNING BODY OF COUNTY SERVICE AREAS NO. 17 – SAN DIEGUITO
EMERGENCY MEDICAL SERVICES DISTRICT ADOPTING LEVIES AND
CONFIRMING REPORTS RE: SPECIAL TAXES TO BE COLLECTED ON THE TAX
ROLL FOR FISCAL YEAR 2025-26**

WHEREAS, County Service Areas (CSA) were formed under Government Code Section 25210, et seq. or the predecessor to these sections; and

WHEREAS, recodification of the Government Code in 2009 moved the authority to collect CSA assessments and special taxes on the tax roll from former Sections 25215.66a and 25210.77a to Sections 25125.2 and 25215.5 of the Government Code; and

WHEREAS, Government Code Sections 25125.2 and 25215.5(b) authorize the collection of charges on the tax roll in a manner consistent with former Sections 25215.66a and 25210.77a; and

WHEREAS, Government Code Section 25210.3(d) provides that “any... ordinance, resolution, regulation, rule, or any other action of the board taken pursuant to the former Chapter 2.2 before January 1, 2009, shall not be voided solely because of the enactment of this chapter or any error, omission, informality, misnomer, or inconsistency with this chapter”; and

WHEREAS, pursuant to Sections 25210.3(d) and 25210.77a of the Government Code and applicable County ordinances, the Board has determined that levies for providing specified miscellaneous extended services by County Service Areas No. 17 - San Dieguito Emergency Medical Services District for Fiscal Year 2025-26 shall appear as a separate item on the tax bill and shall be collected at the same time and in the same manner as ordinary County ad valorem property taxes are collected; and

WHEREAS, the Director, San Diego County Fire, has prepared written reports describing each parcel of real property receiving particular miscellaneous extended services and the amount of the assessments for each parcel for Fiscal Year 2025-26, computed in conformity with the procedures set forth in, and the levies prescribed by, the applicable ordinances and resolutions of the County Service Areas; and

WHEREAS, such reports were prepared and are on file in the Office of Private Road and Landscape Maintenance and Notice of Hearing thereon given as required by law; and

WHEREAS, pursuant to such notice, on June 25, 2025, a hearing was held on said reports; and

WHEREAS, the Board of Supervisors has heard and considered all objections and protests to said reports and to the assessments set forth therein.

NOW THEREFORE IT IS RESOLVED, DETERMINED AND ORDERED AS FOLLOWS:

1. All objections and protests to said reports have been heard and considered and are overruled.
2. Each and every levy set forth in said reports is adopted.
3. Said reports are hereby confirmed.
4. Copies of said reports as confirmed by the Board shall be immediately transmitted to the Auditor and Controller in order that the special taxes may be collected on the tax roll as provided in Government Code Sections 25210.3(d) and 25210.77a and applicable County ordinances.
