# **BOARD POLICY STATEMENTS:**

Board Policy A-87, Competitive Procurement – Authorize single source procurement for parking services from ACE Parking Inc.

<u>Item and Service and Term Period:</u> Secure, covered parking spaces for one-year and four (4) option years, beginning on July 1, 2025, through June 30, 2030, and an additional six (6) months, if needed.

Benefits to the County of San Diego: Contracting with ACE Parking Inc. will protect County vehicles and assets. The proximity of the garage will create efficiency in operations by minimizing staff nonproductive time costs.

<u>Justification: A-87(1)(D)(3):</u> This procurement is for services from a provider with a unique ability not available from other sources. The amount of available parking at the Hall of Justice is inadequate to satisfy all the District Attorney's parking needs. ACE Parking Inc. is the only service provider that could continue to accommodate the estimated 200 parking spaces required within a two-block radius of the Hall of Justice.

<u>Fair and Reasonable Price:</u> The monthly fee for the Columbia Street parking garage is \$220 per parking space. The monthly fee for other lots that could accommodate 200 parking spaces withing a two-block radius of the Hall of Justice was \$250 per parking space. The pricing for ACE Parking Inc. has been determined to be fair and reasonable based on this comparison.
