BACKGROUND



November 2002

Migration from mainframe to best of breed enterprise resource planning applications that included Oracle Financials, PeopleSoft for Human Resources, and Kronos for Timekeeping.

December 9, 2008 (32)

Board recommendation for Request for Proposal for the Oracle Financials upgrade.

November 2011

Completed the upgrade of Oracle Financials, implemented Data Warehouse and Oracle Fusion Middleware.

May 2022

Completed Upgrades of Kronos Timekeeping



- Replatform to Software-as-a-Service
- Timeline of overall project
- Single go-live
- Exit data center by December 2028
- Extended support for current systems
- County and product Subject Matter Experts

- Independent contractor input
- Completed requirements
- Drafted Request for Proposal Documents



RECOMMENDATION



- Authorize a competitive solicitation for County ERPs
 - Contingent on feasibility study award a three-year contract
- Conduct a feasibility study
 - If found to have positive return then add to the 2026/27 Op Plan, and subject to the approval of the Chief Financial Officer
