RESOLUTION OF THE SAN DIEGO COUNTY BOARD OF SUPERVISORS EXERCISING THE POWERS OF THE MOSQUITO ABATEMENT AND VECTOR SURVEILLANCE AND CONTROL DISTRICT ADOPTING SERVICE CHARGES AND CONFIRMING REPORTS REGARDING LEVIES TO BE COLLECTED ON THE TAX ROLL FOR THE FISCAL YEAR 2025-26.

WHEREAS, pursuant to Section 25842.5 of the Government Code, the Board of Supervisors is authorized to provide the services and exercise the powers of a Vector and Control Program, pursuant to Chapter 1 (beginning with Section 2000) of Division 3 of the Health and Safety Code; and

WHEREAS, the service charges that help to support the Vector and Control Program were established in accordance with the law applicable when those charges were approved and last adjusted; and

WHEREAS, these service charges have not been increased following the electorate's approval of Proposition 218 in 1996 and of Proposition 26 in 2010, and therefore are not subject to the additional requirements, restrictions, and procedures established by those enactments; and

WHEREAS, the County has caused to be prepared a written report describing each parcel of real property receiving said services and the amount of the charges for each parcel for Fiscal Year 2025-26, computed in conformity with procedures set forth in, and the charges prescribed by, the applicable ordinances and resolution of the County; and

WHEREAS, such reports were prepared and are on file in the Office of the County Clerk, and Notice of Hearing thereon has been given as required by law; and

WHEREAS, it is resolved the Board of Supervisors hereby define three subregions and levy service charges for Vector Control Program services for Fiscal Year 2025-26 according to the following service charge schedule:

FISCAL YEAR 2025-26 SERVICE CHARGE SCHEDULE

SUBREGION 1: COASTAL SUBREGION consisting of the Cities of Carlsbad, Coronado, Del Mar, Encinitas, Imperial Beach, Oceanside, San Diego, and Solana Beach and Unincorporated Areas included in the following School Districts: Cardiff, Del Mar, Encinitas Union, Rancho Santa Fe, Solana Beach, San Ysidro, South Bay Union, Unified Coronado, Unified Carlsbad, Unified Oceanside, and Unified San Diego;

SUBREGION 2: INLAND SUBURBAN SUBREGION consisting of the Cities of Chula Vista, El Cajon, Escondido, La Mesa, Lemon Grove, National City, Poway, San Marcos, Santee and Vista and Unincorporated Areas included in the following School Districts: Cajon Valley Union, Chula Vista City, Escondido Union, Lakeside Union, La Mesa-Spring Valley Union, Lemon Grove, National City, San Pasqual Union, Santee, Valley Center Union, Unified Poway, Unified Ramona, Unified San Marcos, and Unified Vista;

SUBREGION 3: INLAND RURAL SUBREGION consisting of the areas included in the following School Districts: Alpine Union, Bonsall Union, Dehesa, Fallbrook Union, Unified Borrego Springs, and Unified Mountain Empire.
