Janaayo 2014 – Hufnaanta iyo Mas'uuliyadda Iyadoo Adeegsanaysa Qalabka Gobolka (TRUST Act), Golaha Wakiilada Bill 4, kaas oo xaddiday duruufaha ay hayn karaan shaqsiyaad u matalaya hay'adaha soo-galootiga federaalka






