Project Description: The project consists of the third lease amendment with San Diego Ventures LLC to reduce office space within an existing building by 23,868 square feet, reducing the number of reserved parking spaces to 50 spaces on the east parking lot, and to allow for early termination of the lease. The County will continue to occupy 9,357 square feet of space of the existing building.

Further, no exceptions listed in CEQA Guidelines Section 15300.2 apply to the project. Additionally, the project will not impact environmental resources of hazardous or critical concern that are designated, precisely mapped and officially adopted by government agencies; does not contribute to cumulative environmental impact; will not have a significant impact on the environment due to unusual circumstances; does not damage scenic resources within a designated state scenic highway; and is not on the list of Hazardous Waste and Substance Sites pursuant to Section 65962.5 of the Government Code.
