BOARD POLICY STATEMENTS:

Board Policy A-87: A waiver for Board Policy A-87, Competitive Procurement, is requested. A single source contract with SDG&E for the regional helicopter program meets the requirements in Board Policy A-87, 3A3. SDG&E is the only available funding source for this firefighting helicopter support and the request to extend the current agreement maintains a continuity of services that provide wildfire protection to residents in the region. Additionally, under Board Policy A-87, 3A2, the request to purchase a Sikorsky S70 from SDG&E ensures standardization and continuity of operations with CAL FIRE pilots, who will operate the helicopter on behalf of the County. Finally, a single source contract with United Rotorcraft is requested to outfit the helicopter to meet CAL FIRE's operational standards. United Rotorcraft has the exclusive right to modify the Sikorsky S70 helicopter and meets the requirement in Board Policy A-87, 2A5.
