SUMMARY OF PROPOSED ORDINANCE

Notice is Hereby Given that the Board of Supervisors of the County of San Diego will consider for adoption: An amendment to the San Diego County Compensation Ordinance establishing compensation relating to the ratified tentative agreement with the San Diego County Probation Officers' Association and other compensation adjustments. The amendment would revise one salary grade, provide a step increase for the Supervising Probation Officer classification and update the representation and benefit statuses for one class.

On May 19, 2026, and June 9, 2026, the Board meets at 9:00 a.m., in Room 310, County Administration Center, 1600 Pacific Highway, San Diego, California. Interested persons are encouraged to review the text of the proposed ordinance in detail.
