B-29, Fees, Grants, Revenue Contracts - Department Responsibility for Cost Recovery

### **BOARD POLICY STATEMENTS:**

Board Policy B-29 mandates that departments seek to recover the full cost, to the extent legally possible, of all services provided to agencies or individuals outside of the County of San Diego through grants, contracts or, where they may be charged fees. Reimbursement through grants, contracts or fees will be for the full cost of all services, with certain exceptions approved by the Board of Supervisors.

A waiver of Board Policy B-29 is requested to continue previously directed fee waivers, such as structures damaged or destroyed by natural disasters, modifications to the homes of disabled veterans, and plan check and inspection fees for the Homeowner and Business Owner Relief Act permits.
