





#### COST:

On 7/16/24, "the Board allocated \$11.1 million in planning, design and construction costs for this project which commenced in the same year."

"Caltrans can sell the property directly to the County at market rate, which is estimated to be approximately \$2 million."

"Staff estimate this program's ongoing operational costs at approximately \$3.6 million per year."

IF the project succeeded over 15 yrs AND cost are controlled/managed as estimated: Land 2 million (if CTC and FHWA approve)
Build 11.1 million

Annually 3.6 million x 15 years=54 million

15-year total cost=\$67.1 Mil

BY INDIVIDUAL:

"This emergency housing program is expected to serve on average 70 individuals on any given night and 140 individuals annually...."

140 individuals per yr x 15 yrs=2,100 individuals

\$67.1/2,100=\$31,952 per individual per yr

\$31,952/12 mths=\$2,663 per individual per mth
