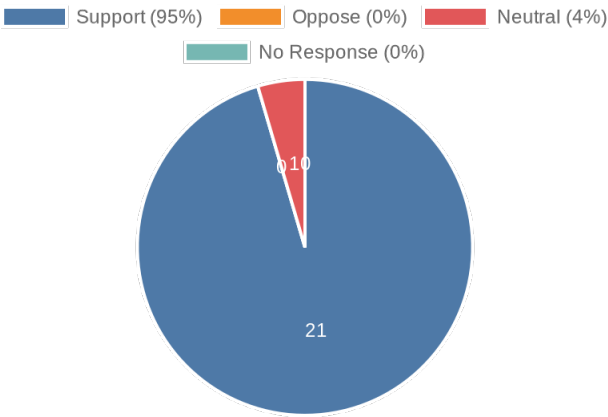

Overall Sentiment

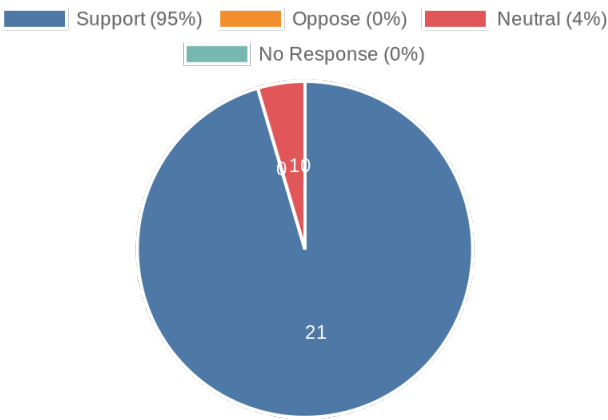

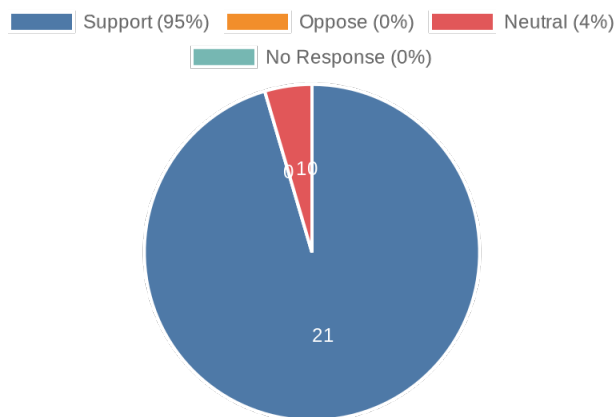

We are happy to see the County bring forward an ordinance modeled off of the City of San Diego's Due Process and Safety Ordinance.

However, the County's version is missing some important pieces that the City's version had, namely the parts that increase transparency and accountability when the San Diego Police Dept. participates in joint task force operations, and clarify law enforcement's role when responding to immigration enforcement by requiring a report of the incident.

The public has a right to know how our county resources and local law enforcement are used in these situations. By requiring additional reporting on joint task forces and providing an incident report any time local law enforcement responds to immigration enforcement, it provides the clarity, transparency and accountability needed to build community trust and keep all San Diegans safe. We ask the board to add these important pieces from the San Diego City ordinance into the County one.

It is clear that ICE and the Border Patrol (BPS) have far exceeded their legal authority and engaged in overly hostile and violent activity. But this proposed ordinance doesn't do the job.

The exceptions in the ordinance (Sec. 957) make it essentially unenforceable. Federal law enforcement agency personnel or out-of-state law enforcement personnel could simply claim it's an inspection under regulatory authority, just as they've lied so often in the past; and saying "In response to an imminent threat to life or public

safety pursuant to a narrowly tailored policy adopted by the Chief Administrative Officer" without specifying the policy is so vague that it would not stand up in Court.

Similarly, agents at airports should not be excepted generically (Sec. 970.) Some of these ICE arrests are at airports.

But now that ICE and BPS are under extreme fire for their lies and unconstitutional actions, my inclination is to let them self-implode.
