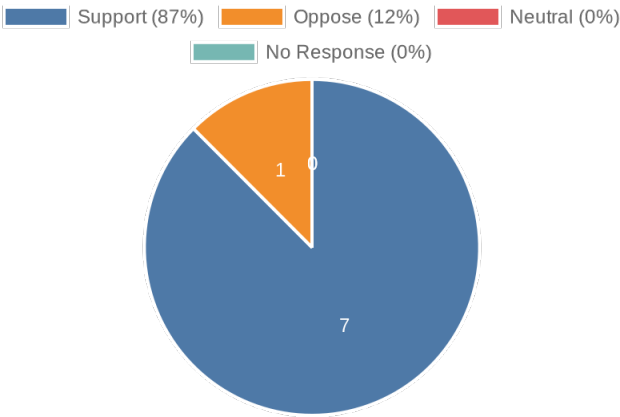

Overall Sentiment

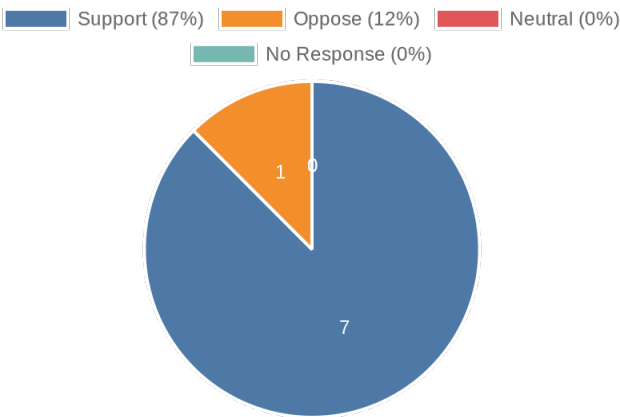

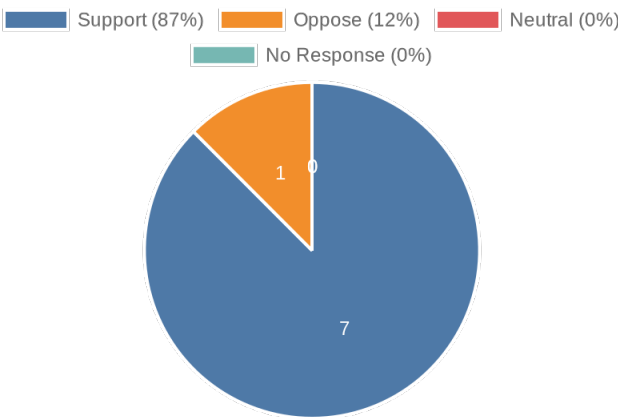
