The Board of Supervisors met in closed session on April 22, 2026, from 2:18 p.m. to 3:40 p.m. All five Board members were present for all items, except Chair Pro Tem Aguirre was only present for items B and C, and Supervisor Desmond was not present for items A, G, and H.

The Board took the following reportable actions:

On Item 25B, by a vote of 4-1, with Supervisor Desmond voting “No,” the Board authorized County Counsel to initiate litigation. Particulars about the litigation will be disclosed to any person upon inquiry, after litigation has formally commenced.

On Item 25H, Estate of Omar Moreno Arroyo v. County of San Diego, et al., the Board, by a vote of 3-0, authorized County Counsel to appeal the district court’s ruling on summary judgment denying qualified immunity to several County employees.
