**A RESOLUTION OF THE SAN DIEGO COUNTY BOARD OF DIRECTORS OF THE SAN
DIEGO COUNTY FIRE PROTECTION DISTRICT TO ACCEPT THE REPORT OF THE
COMPLETION OF THE FISCAL YEAR 2024-25 FIRE INSPECTIONS**

WHEREAS, California Health and Safety Code Sections 13146.2 and 13146.3 require fire agencies to perform annual inspections on any building used as a school, camp, apartment complex, boarding facility, hotel, motel, care facility, church, police station, sheriff station, courthouse, jail, or prison; and

WHEREAS, California Health and Safety Code Section 13146.4 requires fire agencies to annually report to their governing boards their compliance with the annual inspection requirement; and

WHEREAS, San Diego County Fire completes the mandated inspections on behalf of the San Diego County Fire Protection District, and Deer Springs Fire Protection District; and

WHEREAS, in Fiscal Year 2024-25, San Diego County Fire completed 100% of the mandated inspections, totaling 286 mandated inspections at 73 schools, 24 camps, 76 apartment complexes/ boarding facilities, 73 hotels/motels, 29 care facilities, 2 churches, 5 police stations/sheriff stations/ courthouses, and 4 jails/prisons.

WHEREAS, in addition to the mandated inspections, San Diego County Fire completed 1,222 non-mandated business inspections during the past fiscal year; and

NOW, THEREFORE, IT IS HEREBY RESOLVED that

1. The above recitals are true and correct and are incorporated herein as if set forth in full and are relied upon independently by the Board of Directors of the San Diego County Fire Protection District for its adoption of this resolution.
2. The Board of Directors of the San Diego County Fire Protection District acknowledges receipt of County Fire's report of State-mandated inspections, as required by California Health and Safety Code Section 13146.4.


