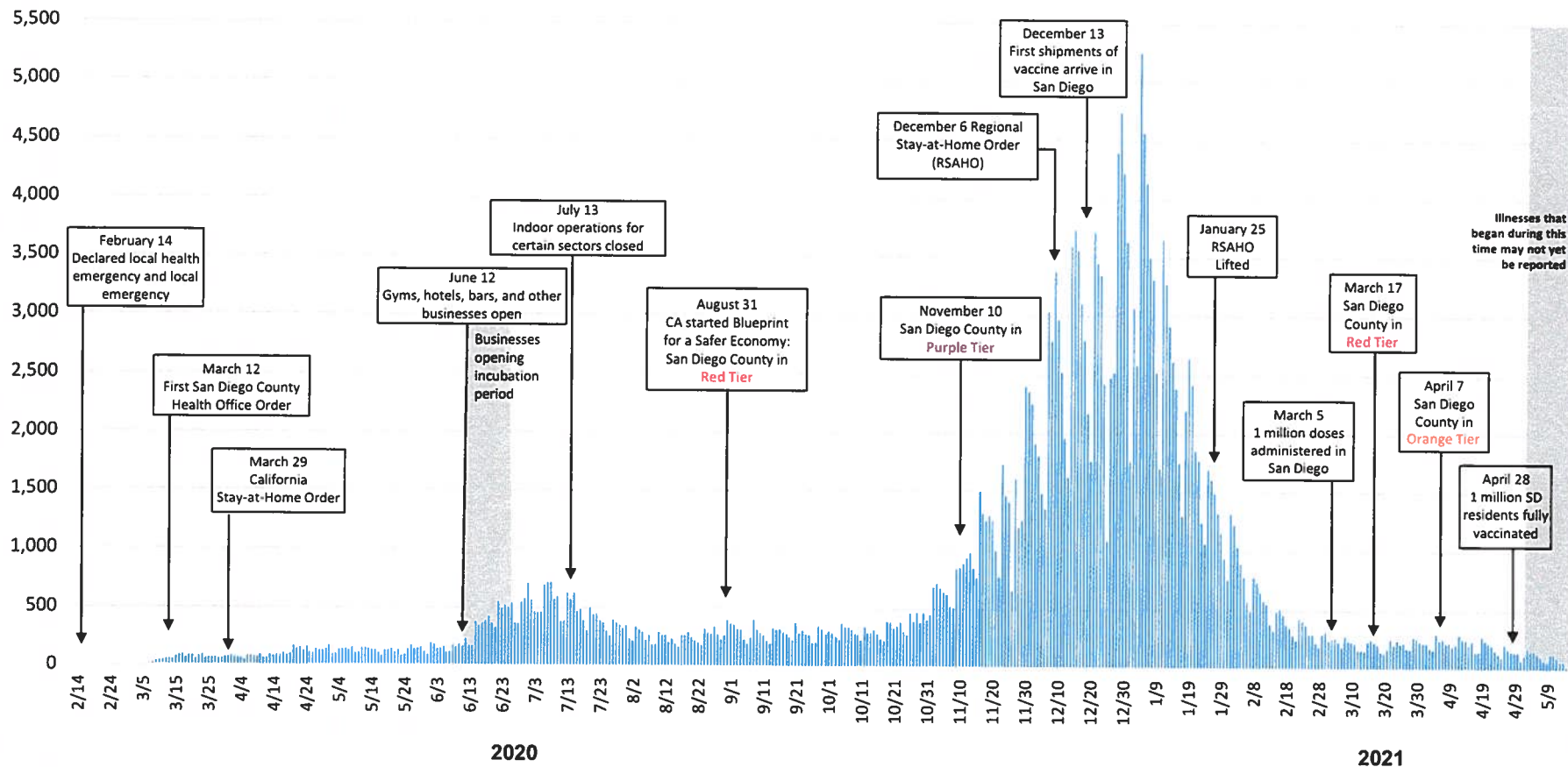

Confirmed COVID-19 Cases by Date of Illness Onset*

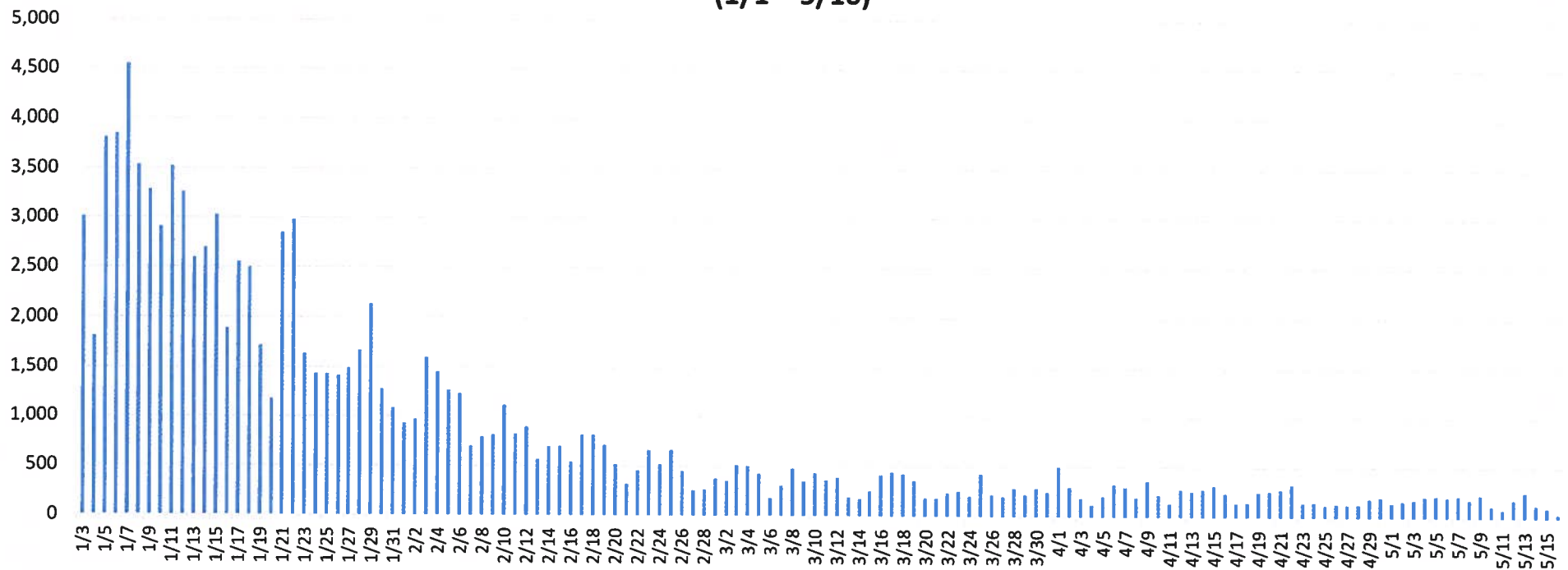

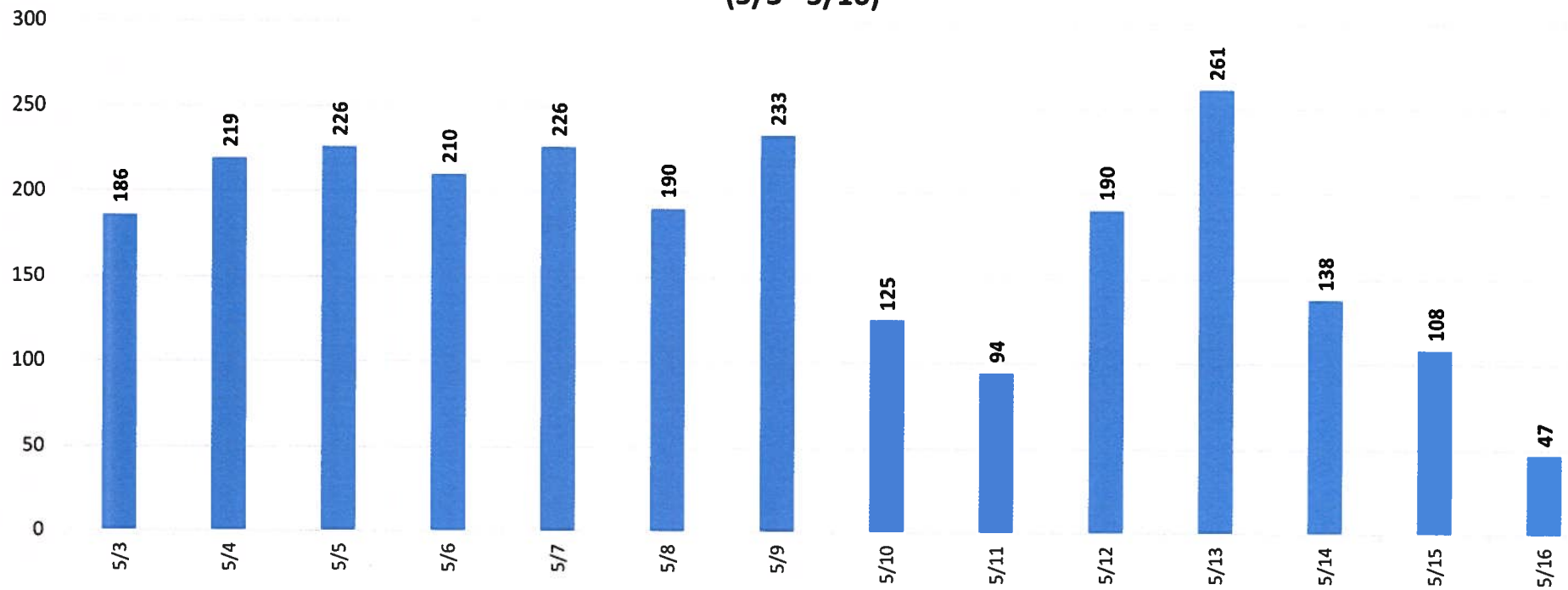
**COVID-19 Cases Among San Diego County Residents

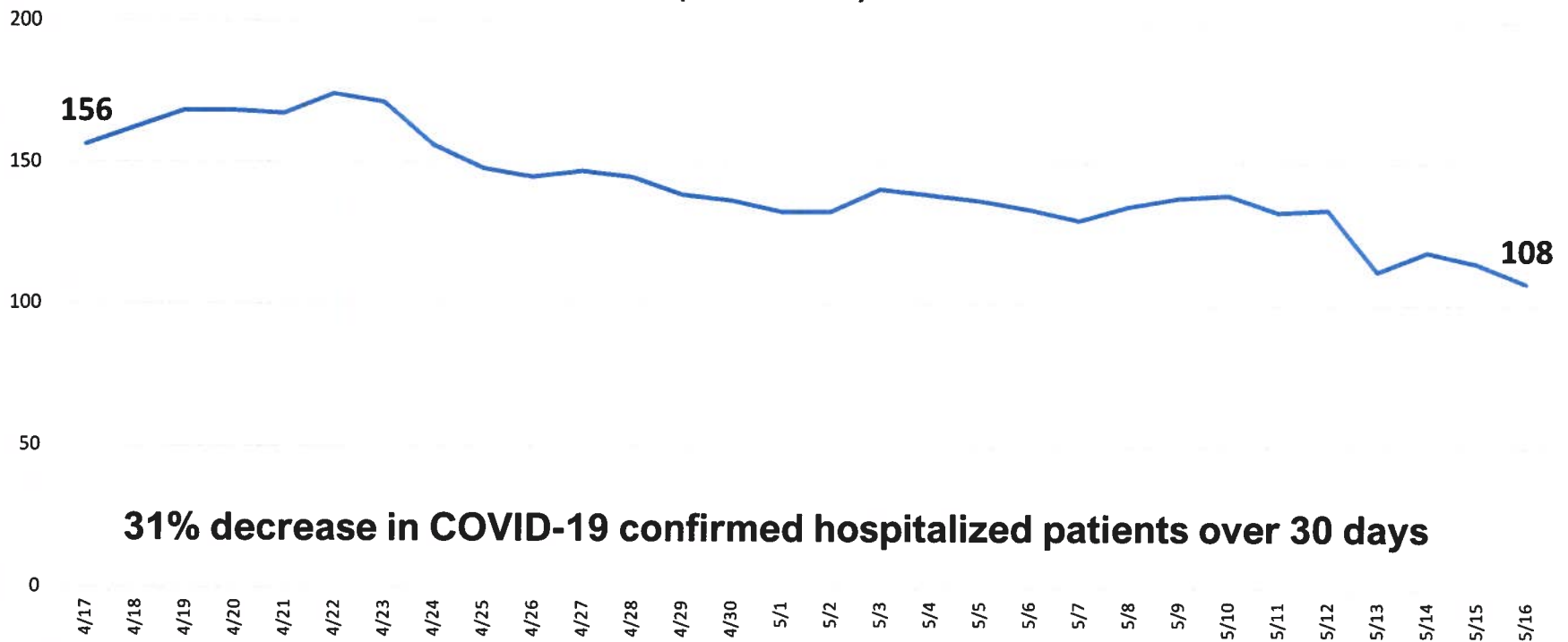

(4/17 – 5/16)**

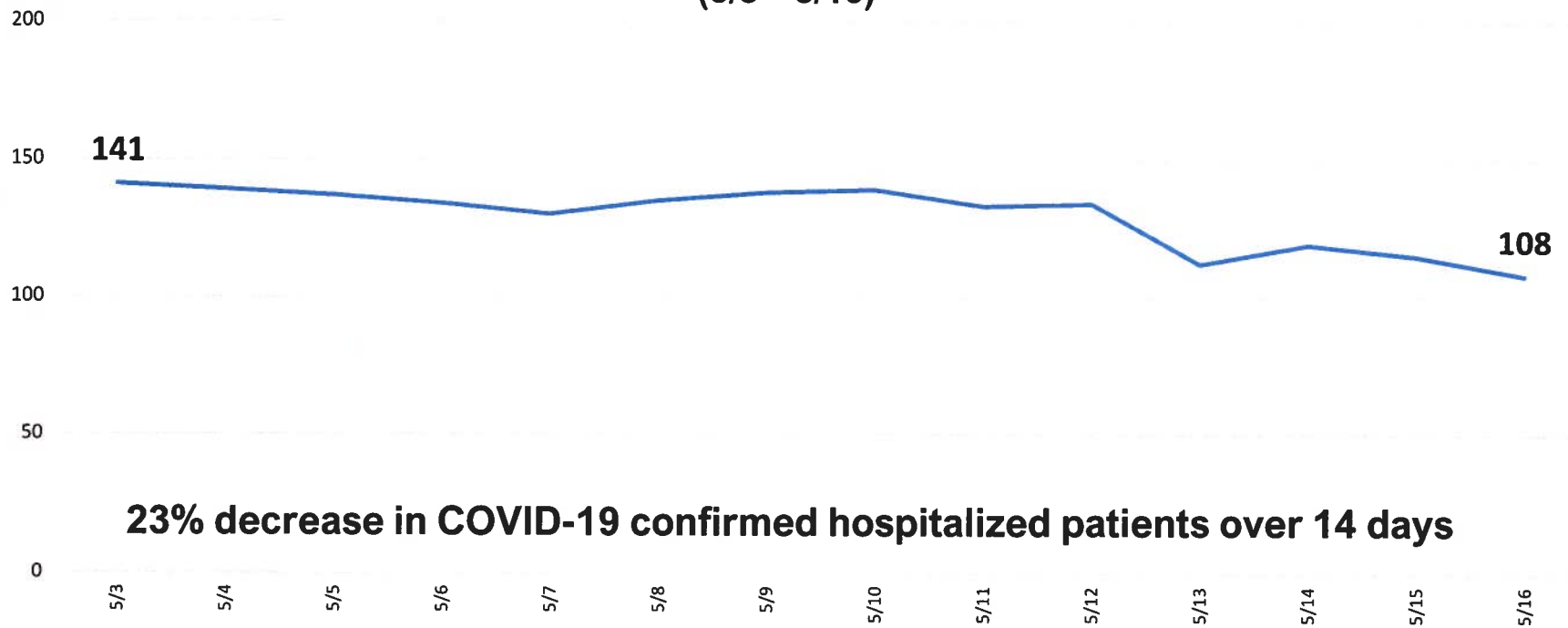

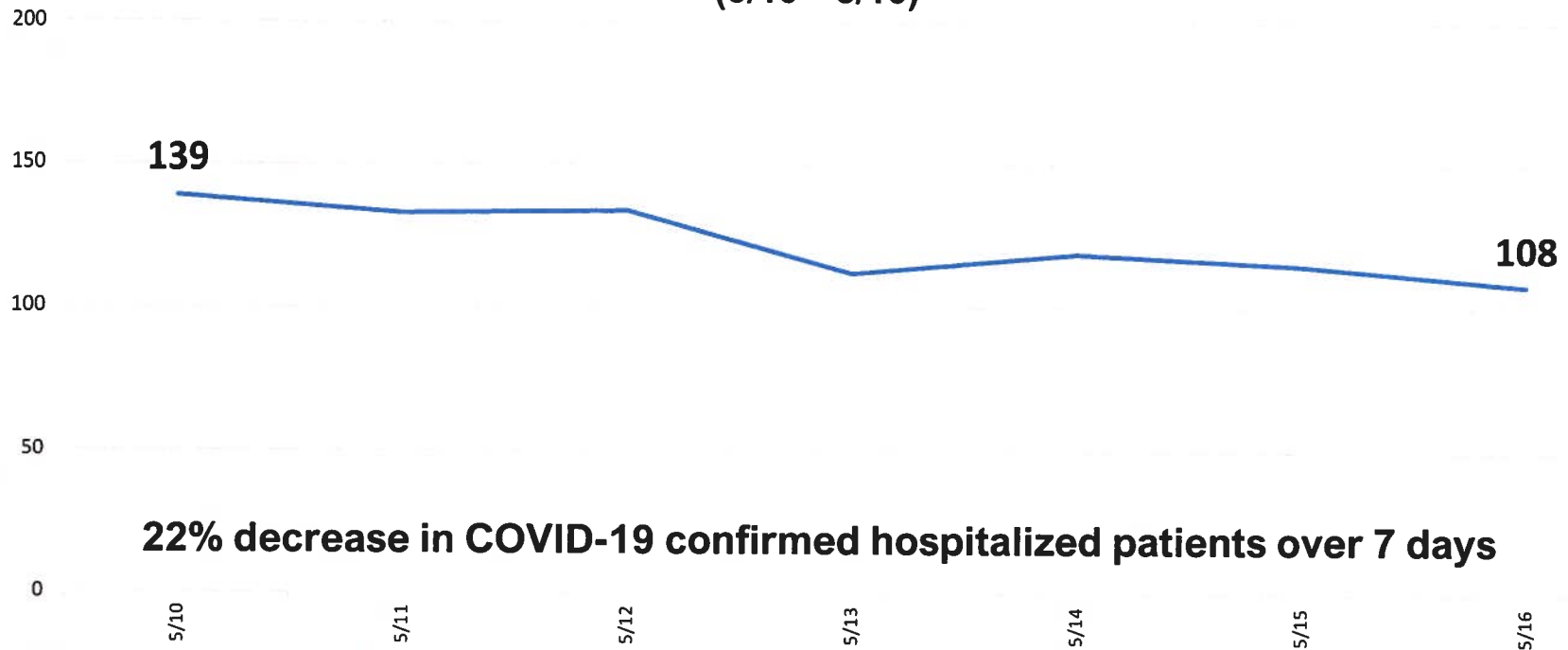
**COVID-19 Confirmed Hospitalized Patients

(5/10 – 5/16)**

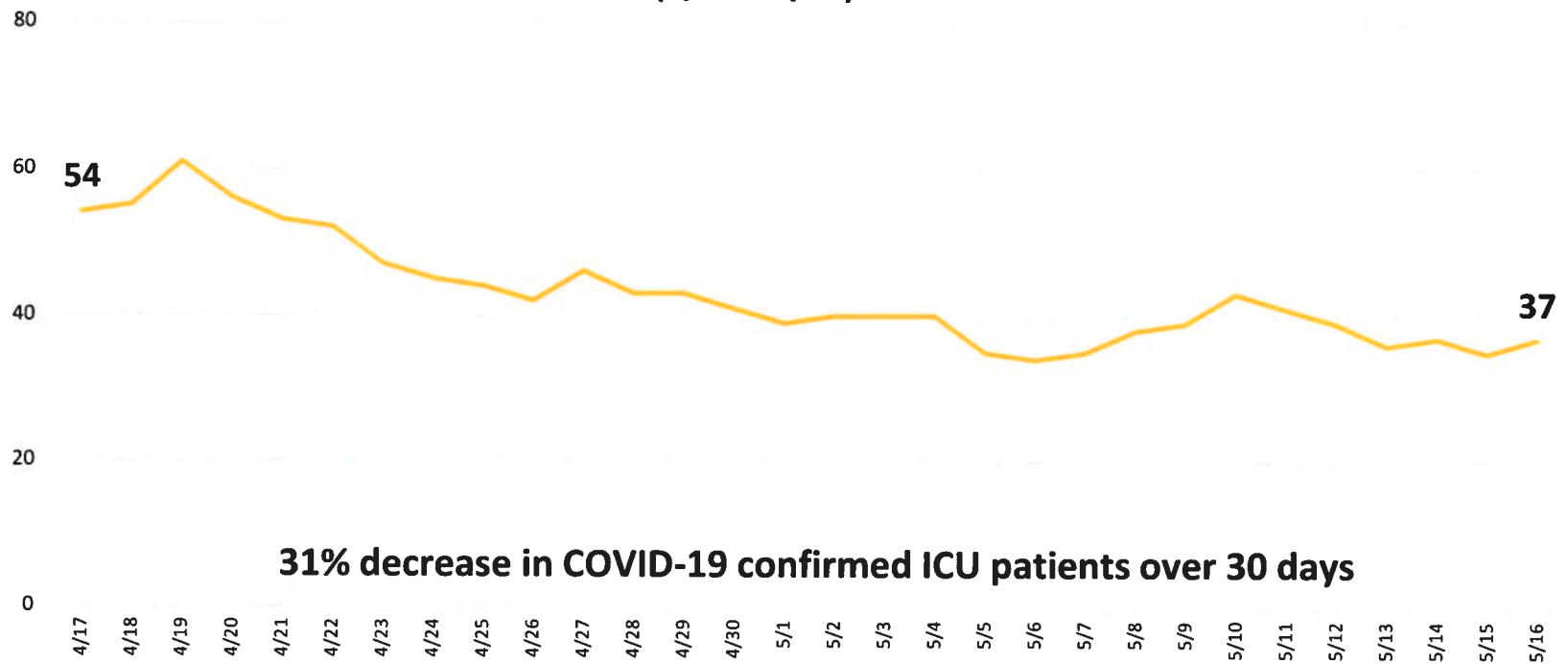

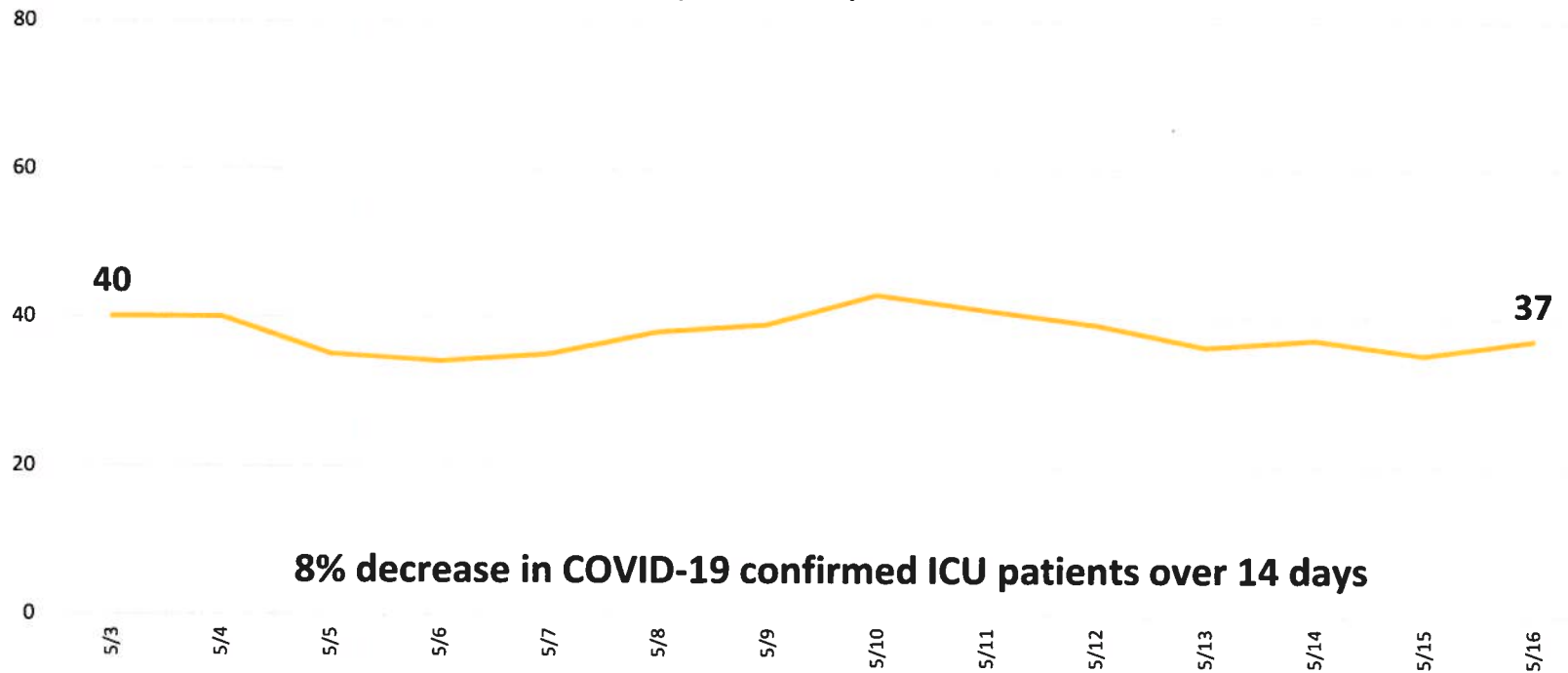
**COVID-19 Confirmed ICU Patients

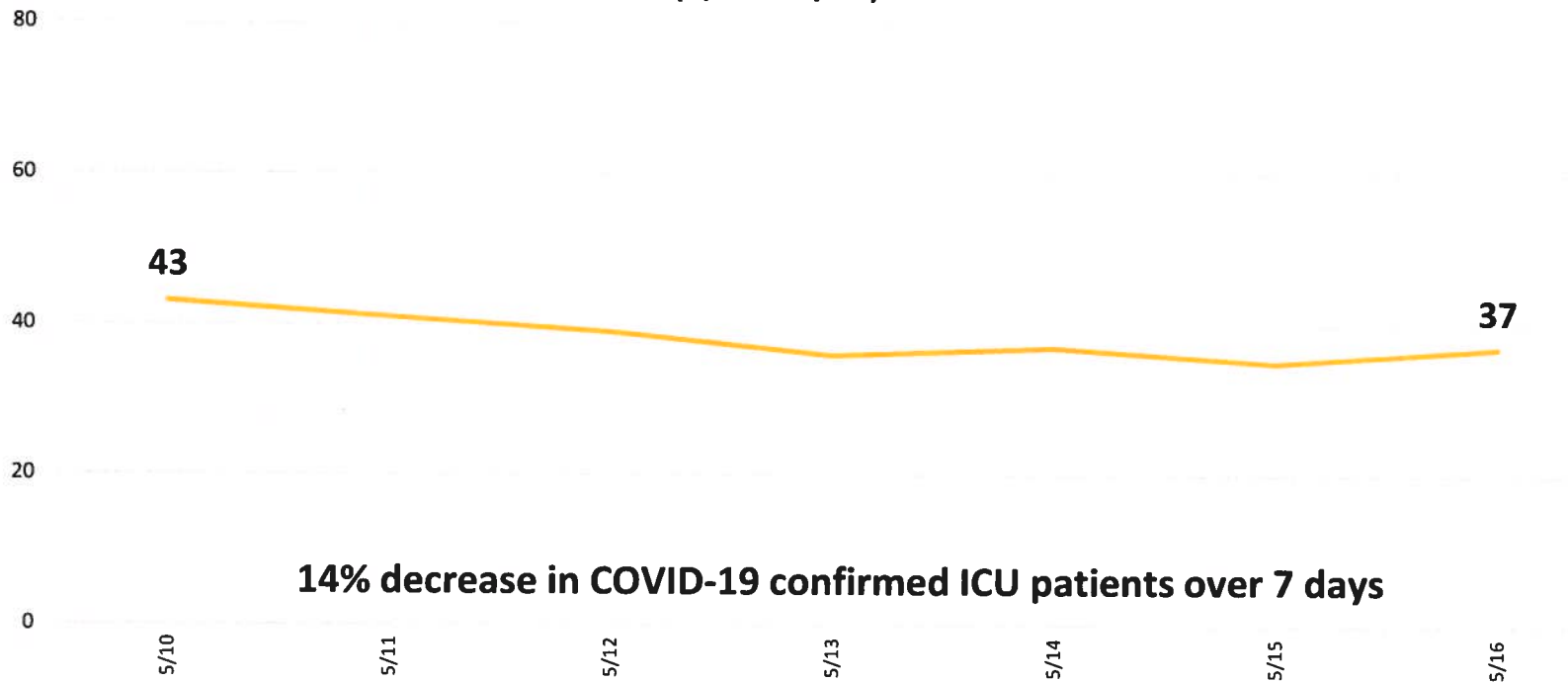

HEALTH OFFICERS ORDER WILL BE MODIFIED WHEN ANY ONE OF THE FOLLOWING THREE CRITERIA ARE MET: COMMUNITY OUTBREAKS, PPE SUPPLY, OR ICU CAPACITY*; **OR** ONE OR MORE OF REMAINING CRITERIA IN AT LEAST 2 OF 3 COLUMNS ARE MET.

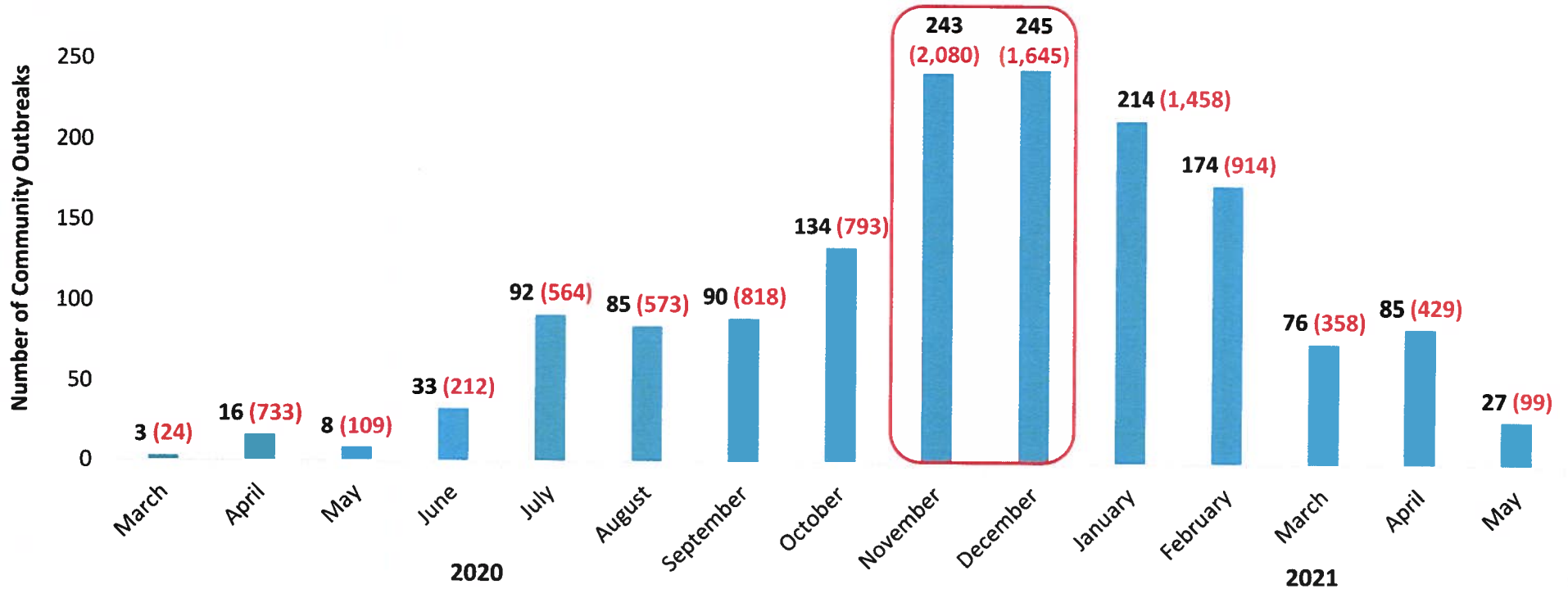

N = 1,525 Outbreaks (10,809 Cases)

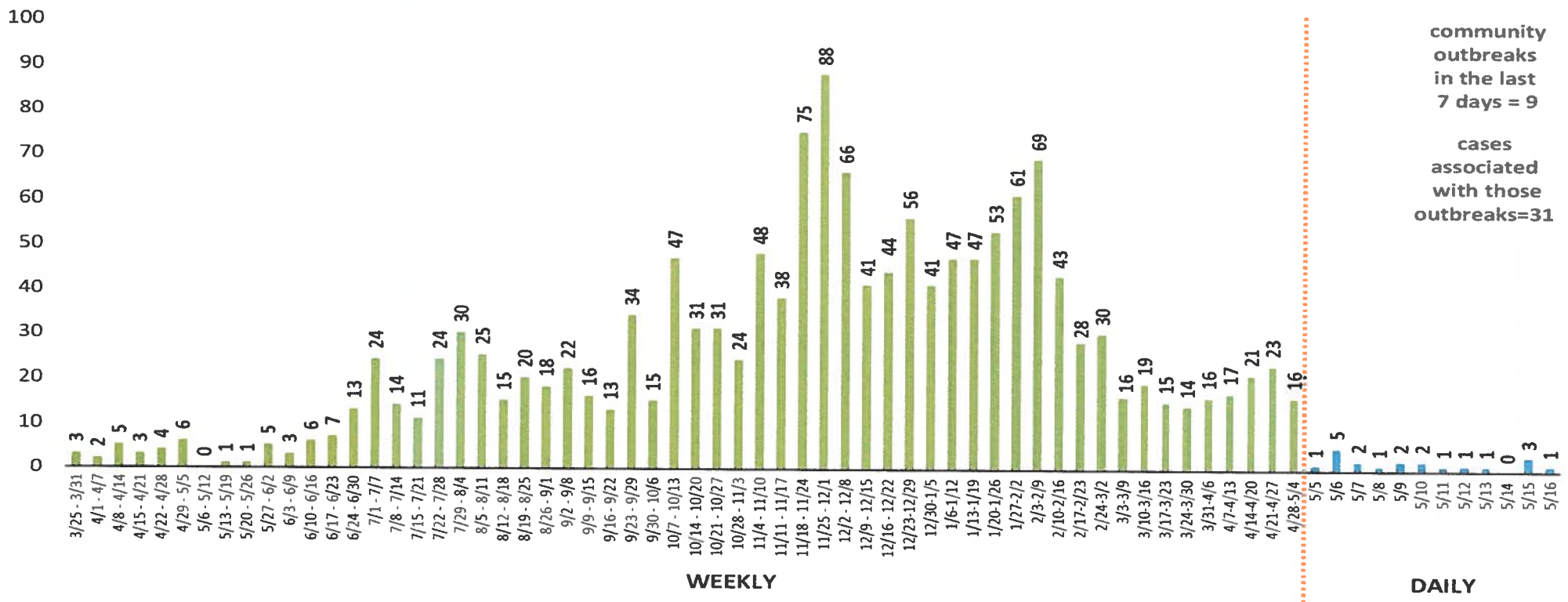

Total Number of Community Outbreaks = 1,525



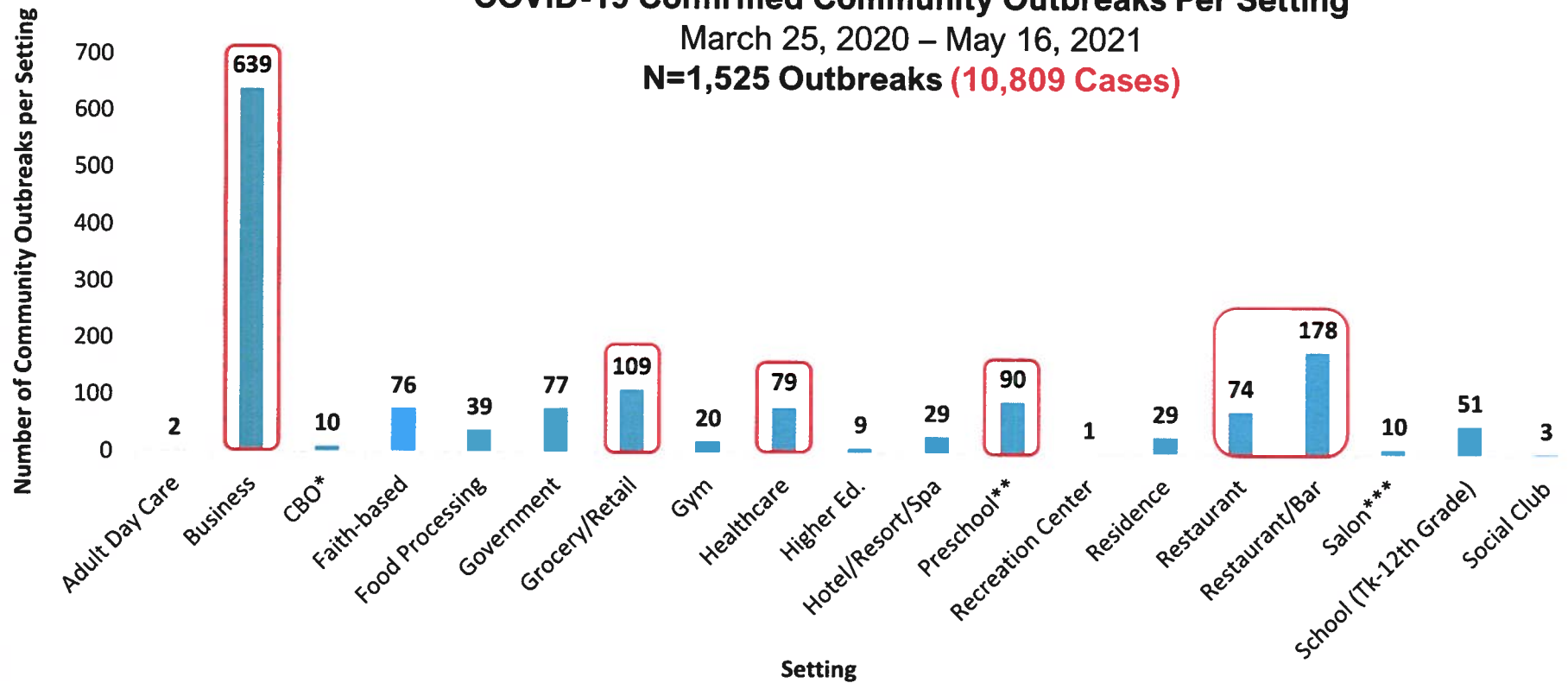

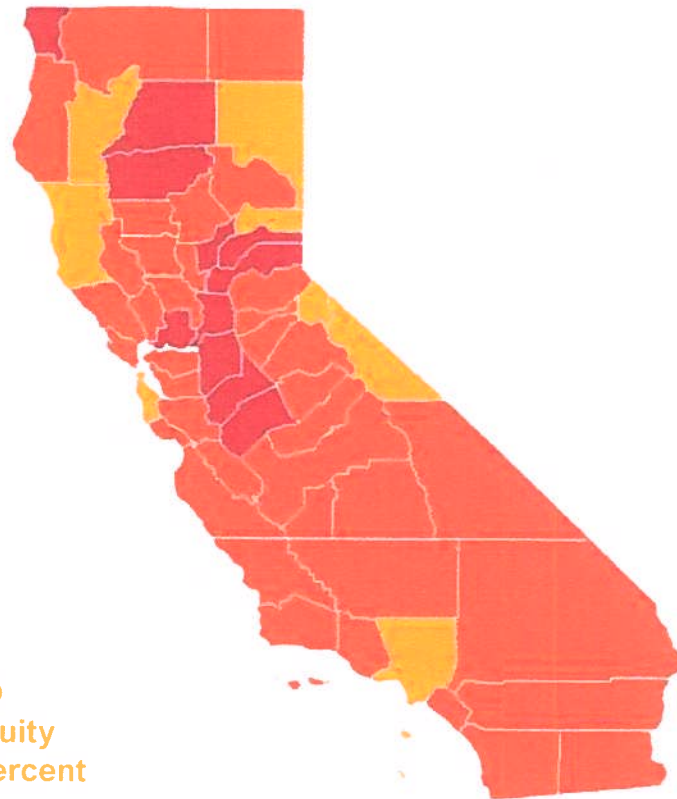

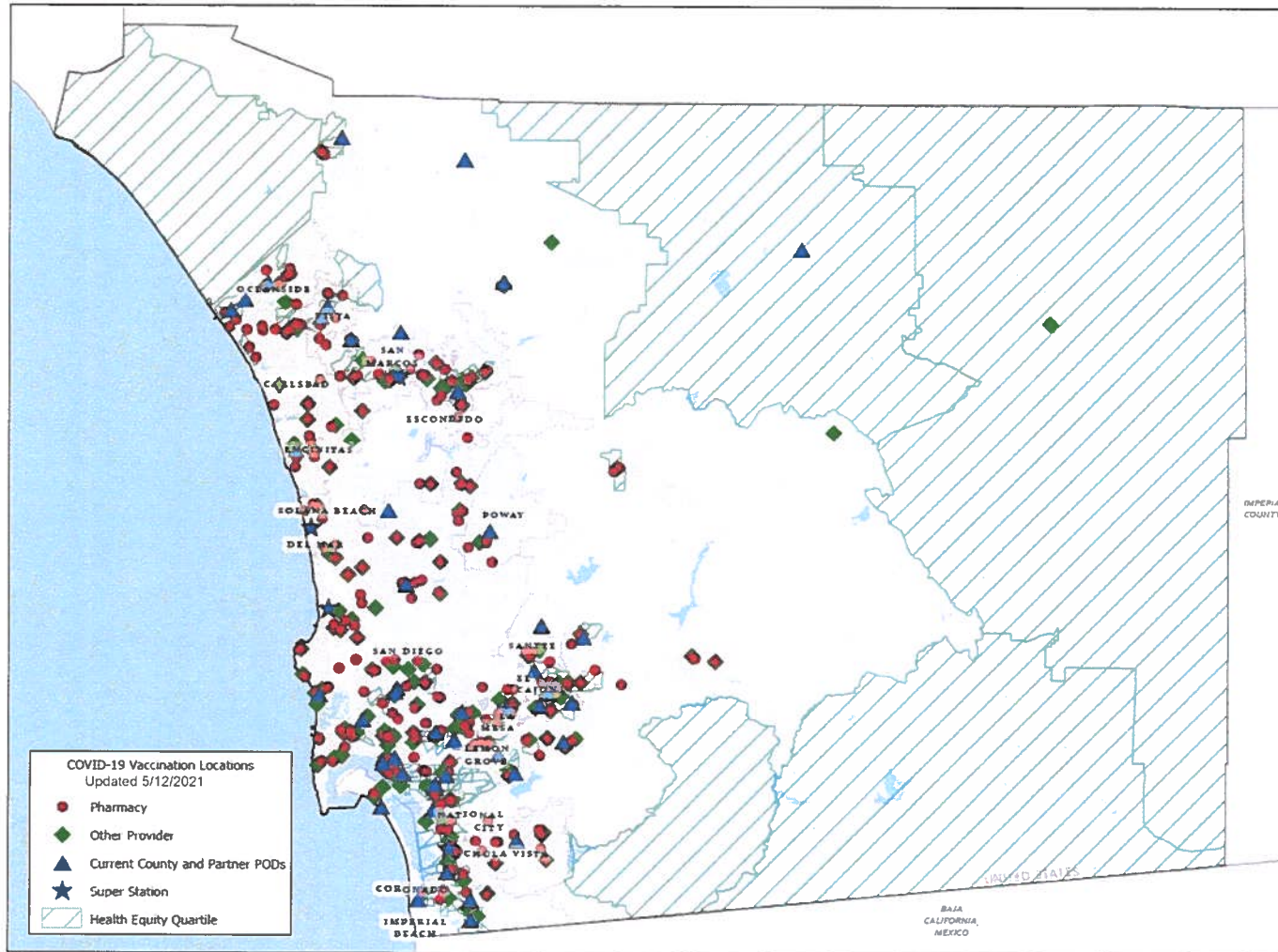

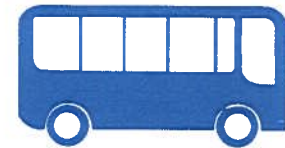

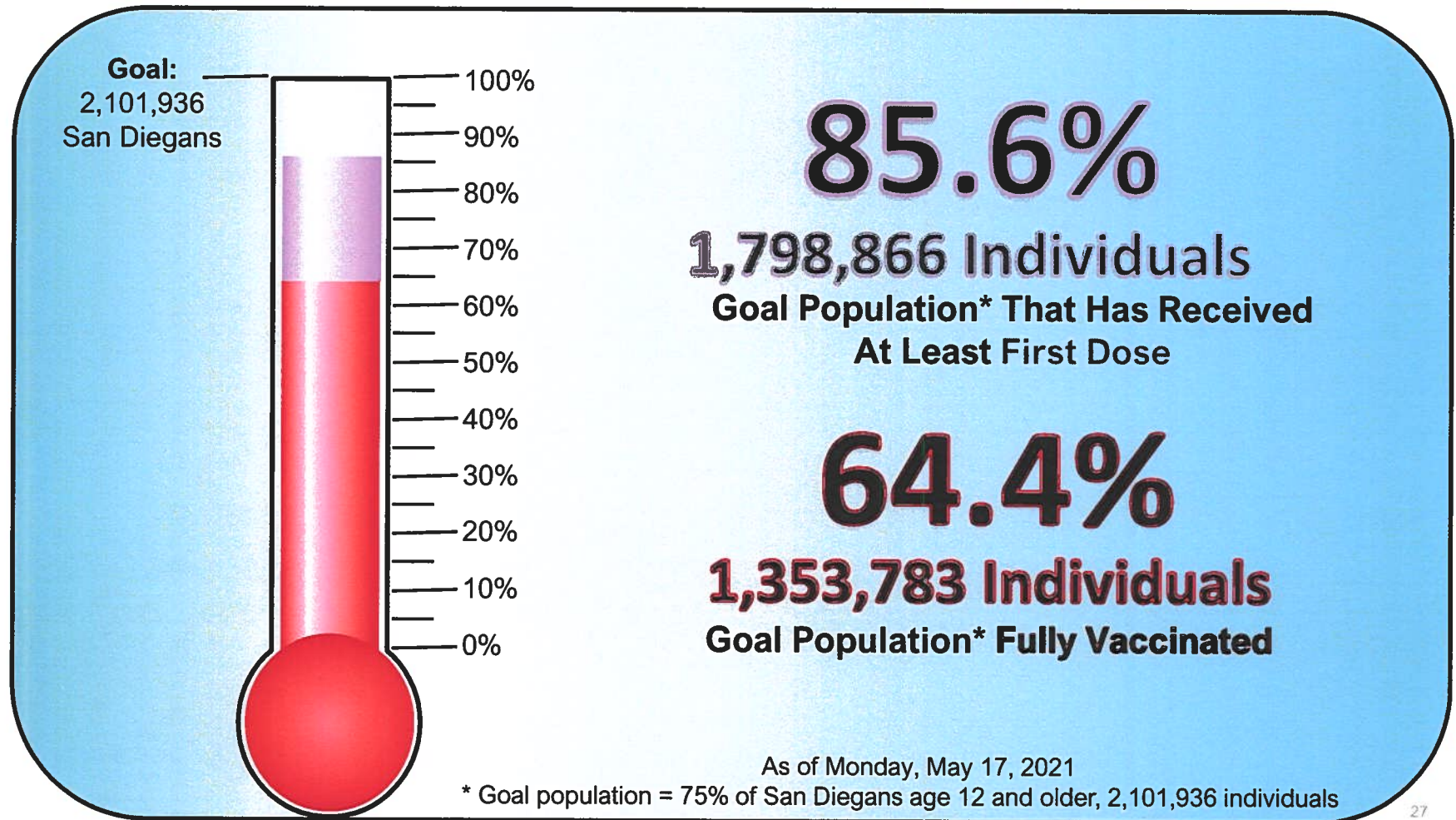

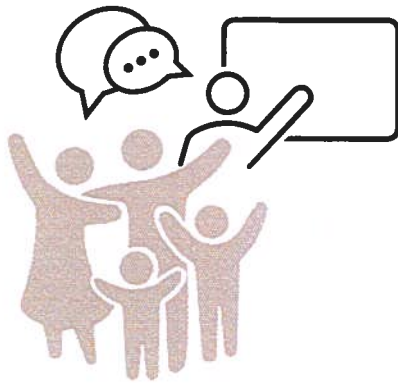

- \$10 Million Estimated Weekly Spend Rate on COVID-19
- \$38.7+ Million New Emergency Rental Assistance Funding
- \$648.4 Million ARPA Allocation for County of San Diego
- ARPA Guidelines Released by US Treasury

ARPA Local Fiscal Recovery Fund Guidelines

- “Interim Final Rule” – comments due by July 9, 2021
- March 3, 2021 – beginning of the ARPA “covered period”
- December 31, 2024 – Recovery Funds must be obligated
- December 31, 2026 – Recovery Funds must be spent
