

**ORDINANCE NO. 10898 (NEW SERIES)**

**ORDINANCE AMENDING SECTIONS 72.161.35.1., 72.164.55., 72.169.52.,  
72.169.62., AND 72.169.62.1., DELETING SECTION 72.169.55., AND ADDING  
SECTION 72.164.55.1. OF THE SAN DIEGO COUNTY CODE RELATING TO  
TRAFFIC REGULATIONS IN THE COUNTY OF SAN DIEGO**

**The Board of Supervisors of the County of San Diego ordains as follows:**

**Section 72.161.35.1. of the San Diego County Code is hereby amended:**

**SEC. 72.161.35.1. VALLEY CENTER.** The prima facie speed limit on Lake Wohlford Road from the easterly city limit of the City of Escondido easterly to the west line of Guejito Road is hereby decreased to and established at 45 miles per hour.

**Section 72.164.55. of the San Diego County Code is hereby amended:**

**SEC. 72.164.55. BONITA.** The prima facie speed limit on Sweetwater Road between the easterly limit of National city (at Plaza Bonita Center Way) and the southerly line of Central Avenue is hereby decreased to and established at 45 miles per hour.

**Section 72.169.52. of the San Diego County Code is hereby amended:**

**SEC. 72.169.52. FALLBROOK.** The prima facie speed limit on Mission Road from a point 860 feet south of the south line of Pepper Tree Lane southerly to the north line of Winter Haven Road is hereby decreased to and established at 45 miles per hour.

**Section 72.169.62. of the San Diego County Code is hereby amended:**

**SEC. 72.169.62. VISTA.** The prima facie speed limit on South Santa Fe Avenue between the easterly limits of the City of Vista (near Montgomery Drive) and the westerly limits of the City of San Marcos (near Smilax Road) is hereby decreased to and established at 40 miles per hour.

**Section 72.169.62.1. of the San Diego County Code is hereby amended:**

**SEC. 72.169.62.1. SAN MARCOS.** The prima facie speed limit on Poinsettia Avenue from South Santa Fe Avenue southerly to Smilax Road is hereby decreased to

**Section 72.164.55.1. of the San Diego County Code is hereby added:**

**SEC 72.164.55.1. BONITA. The *prima facie* speed limit on Sweetwater Road from the northerly line of Central Avenue northerly to the southerly line of State Route 54 Overpass is hereby decreased to and established at 40 MPH.**
