
Voter Education and Outreach State and Federal Mandates (cont.)

Voter Education and Outreach State and Federal Mandates (cont.)

- ▶ California Voter's Choice Act
 - ► Election Administration Plan with Voter Education and Outreach Strategy
 - Collaborative process of public input and in consultation with the Registrar's advisory committees



Scope of Voter Education and Outreach Services

- Five key areas:
 - 1. Voter Education and Outreach Strategy developed with public input
 - 2. Fulltime Voter Outreach Coordinators
 - 3. Translation of election related materials
 - 4. Voter access and language assistance
 - 5. Bilingual in-office and vote center staff with interpreter services available




Fourth Supervisorial District Voter Outreach and Engagement

- General and targeted outreach



Recommended Action

- 1. Adopt the resolution that calls for a Special Election to be held on Tuesday, August 15, 2023. If no candidate receives a majority vote at that election, then a Special General Election would be held on Tuesday, November 7, 2023.
- 2. Direct the Chief Administrative Officer to include \$5.2 million in the Registrar of Voters for the Special Election and Special General Election in the Fiscal Year 2023-24 Operational Plan via the CAO Recommended Operational Plan Change Letter, funding will be based on General Purpose Revenue.
