DELETES FIVE JOB CODES/ CLASSIFICATIONS IN THE CLASSIFIED AND UNCLASSIFIED SERVICE	SECTION 2 Amends Appendix One of the Compensation Ordinance	This action deletes the Assistant Public Administrator/Public Guardian and Public Administrator/Public Guardian/Public Conservator classifications in the unclassified service and deletes the Mental Health Conservatorship Clinician, Senior Deputy Public Administrator/Guardian, and Investigative Technician classifications in the classified service. There are no incumbents in these positions.
RETITLES TWO JOB CODES/CLASSIFICATIONS IN THE CLASSIFIED SERVICE	SECTION 3 Amends Appendix One of the Compensation Ordinance	This action retitles two classifications: Forensic Documents Examiner to Forensic Documents & Impressions Examiner and Senior Forensic Documents Examiner to Senior Forensic Documents & Impressions Examiner.
DESIGNATES TWO JOB CODES/CLASSIFICATIONS AS TERMINAL IN THE CLASSIFIED SERVICE	SECTION 4 Amends Appendix One of the Compensation Ordinance	This action designates the Supervising Deputy Public Administrator/Guardian and Deputy Public Administrator – Guardian classifications as terminal.
AMENDS SECTION 1.8.4	SECTION 5 Section 1.8.4 is hereby amended	This action updates the name of the juvenile detention facility from Kearny Mesa Juvenile Detention Facility to Youth Transition Campus.
AMENDS SECTION 1.8.6	SECTION 6 Section 1.8.6 is hereby amended	This action adds Rock Mountain to the designated detention facility work locations and updates the name of the juvenile detention facility from Kearny Mesa Juvenile Detention Facility to Youth Transition Campus.
AMENDS SECTION 1.8.7	SECTION 7 Section 1.8.7 is hereby amended	This action adds Rock Mountain to the list of detention facility work locations.
AMENDS SECTION 81 OF THE ADMINISTRATIVE CODE	Section 81 is hereby amended	This action amends Section 81 to implement Senate Bill 960 which requires a peace officer to be legally authorized to work in the United States and removes the provision which required a peace officer to be a citizen or permanent resident of the U.S.
