A-128, Comprehensive Homeless Policy

BOARD POLICY STATEMENTS:

The purpose of this policy is to summarize the County of San Diego's (County) comprehensive response to homelessness and align with the Framework for Ending Homelessness adopted by the Board of Supervisors. The County partners with other governmental and private entities to provide a continuum of housing and supportive services to individuals and families at-risk of or experiencing homelessness throughout the region. Cross sector organizations that are critical to ending homelessness include: mainstream housing, physical and/or behavioral health providers, educational institutions, the business community, faith based and philanthropic organizations, social service providers, and the criminal justice system. Provision of housing and supportive services must be addressed by the entire region, including all cities, and demonstrated through appropriate contributions reflected in local jurisdiction budgets and policies. This policy recognizes that poverty, inequitable economic opportunity, and trauma are among the most significant causes of homelessness; and that a comprehensive approach must embrace the economic, physical, and mental well-being of all San Diego County residents.
