#### Overall Sentiment



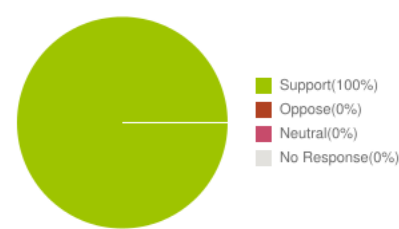

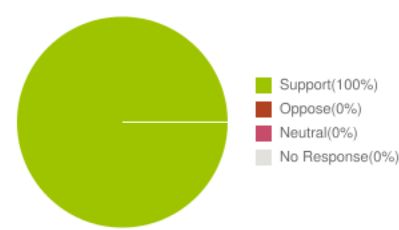
