On February 8, 2022 (11), your Board received a preliminary report that included recommendations to <u>safely reduce jail</u> <u>populations</u> and authorized the <u>enhancement and exploration</u> <u>of sobering services</u>. The report outlined a number of next steps the San Diego Association of Governments (*SANDAG*) will take as they implement their project plan. Today, <u>SANDAG</u> <u>will provide their initial interim report</u>.

Populations of Interest (including but not limited to)

- Individuals with non-violent offenses including public intoxication, encroachment, loitering, and illegal lodging

- Individuals released and monitored on Sheriff's pre-trial services
- Individuals diverted through Mental Health Diversion and other collaborative court options






Research Goal 1:

Produce a data driven analysis on how use of jails changed pre-COVID-19 versus during COVID-19 with a focus on identifying policy interventions that would effectively, safely, and permanently reduce San Diego County jail populations.

Average Daily Jail Populations, 2017-2021





Research Goal 2:

Identify the primary policy drivers of reduced incarceration rates during COVID-19, conduct a population sub- analysis by demographics and geography for the population affected by these policy changes, analyze public safety outcomes associated with these short-term changes in incarceration policy, and recommend policy changes to safely and permanently reduce jail populations and better protect public safety with alternatives to incarceration.

Multiple Methodologies



Analysis of regional crime statistics and relevant policy changes



Analysis of local and County public safety and health data



Community feedback through Advisory Group, surveys, forums, and ongoing dialogue

Methodology & Challenges

- Accurate linking of data across different systems and use of practitioner data for research purposes
- Selection of the "treatment" group individuals out of custody due to COVID-19 policies
- Timeframe to sample "treatment" group to allow sufficient follow-up period
- Historical comparison group using propensity score matching on key variables
- Limitations: lack of random assignment and groups of interest may not be mutually exclusive, other variations over time that cannot be controlled



Research Goal 3:

Develop a set of comprehensive recommendations for shortand long-term actions and investments to expand access to alternatives to incarceration for justice involved individuals who do not pose a public safety threat. What services are available?

What are barriers to receiving services?

What are client needs?

Where do gaps exist?

What are promising and effective programs?

What recommendations should be made regarding implementing or expanding programs to meet needs?






Research Question 4:

Analyze the costs, savings, and long-term fiscal impacts to Public Safety group departments, HHSA, and other aspects of County operations by shifting the County approach to public safety to prioritize "safety through services" and evidence-based alternatives to incarceration.

What savings to the County of San Diego would be realized (1, 5, 10, and 20 years) from having fewer individuals incarcerated locally?

What costs to the County of San Diego would there be (1, 5, 10, and 20 years) associated with providing needed services and programs in the community to individuals?

Alternatives to Incarceration

In December 2021, SANDAG responded to a Request for Proposals (RFP) from the County of San Diego entitled "Data-Drive Approach to Protecting Public Safety, Improving and Expanding Rehabilitative Treatment and Services, and Advancing Equity Through Alternatives to Incarceration." SANDAG was notified by the County that it was selected for this contract, pending successful negotiations.

The County of San Diego released this RFP with an interest of partnering with a research entity who would be able to compile data and work with stakeholders to conduct a data-driven approach to identifying the primary policy drivers of reduced incarceration rates during the period of the COVID-19 global pandemic.

As part of this effort, SANDAG will identify available data, analyze jail population changes, conduct a gap analysis related to services and supports, review best evidence-based practices, make recommendations that incorporate feedback from diverse groups, prepare a comprehensive fiscal analysis, and publish a series of written reports and updates.

Advisory Group

An important component of this project will be ongoing communication and collaboration with an Advisory Group to be formed in March 2022.
