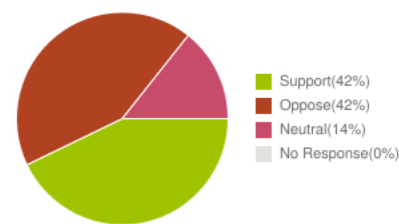

Overall Sentiment



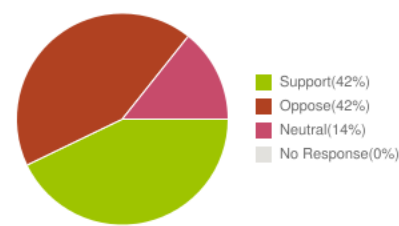

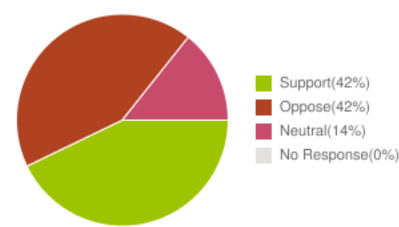
