Overall Sentiment



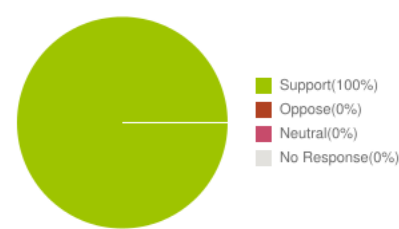

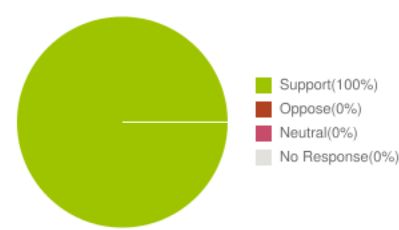
