Chair Vargas and Members of the Board,

The Protect Our Communities Foundation (PCF) applauds the efforts of Supervisor Jim Desmond in bringing forward Agenda Item 09 at the May 24, 2023 Board of Supervisors meeting. Specifically, PCF agrees with Supervisor Desmond that "a better understanding of local conditions relating to existing residential, commercial and other infill renewable energy generation, with an emphasis on existing solar is needed," including "an analysis of remaining rooftop and infill solar capacity in order to provide information that will inform and guide the Board in our decarbonization efforts."<sup>1</sup> To ensure that the Regional Decarbonization Framework (RDF) "is reflective of local reality," and that it "focuses on ratepayer control over their energy needs" and "the wellbeing of every community in the region, for both existing and future generations,"<sup>2</sup> PCF makes three recommendations the Board should incorporate before approving Agenda Item 09.

First, PCF recommends that the Board direct staff to postpone any further actions to implement the RDF, including consideration of the Implementation Playbook,<sup>3</sup> until the necessary study has been completed. Supervisor Desmond's recommended action states that the "study of renewable energy generation, transmission, distribution, and storage capacity in the San Diego region that considers resiliency from power outages, economic benefits and costs, and local community context"<sup>4</sup> is critical to a complete and thorough analysis. PCF agrees. The Technical Report presented to the

Board last August dramatically under-values the region's rooftop solar potential and the cost of transmission line construction; fails to quantify the benefits of customer generated solar or account for parking lot solar potential; and over-values the region's 2050 electricity demand and commercial rooftop solar costs. The Technical Report must be revised and updated to correct these deficiencies and incorporate the results of the study proposed by Supervisor Desmond.

Second, PCF recommends that the Board expedite the recommended analysis and direct completion of the study by the end of this year. No need exists for a two- or two-an-a-half-year contract<sup>5</sup> -- the necessary analysis can and should be completed in weeks or months, not years. Expediting the study will help ensure that San Diego Gas & Electric Company (SDG&E) ratepayers are not burdened with unnecessary, expensive, and environmentally harmful new transmission line construction as described in recent reports that are envisioned by SDG&E.<sup>6</sup> Investor-owned utility companies like SDG&E profit excessively from expensive capital projects and thus favor the development of remote, utility-scale projects that require new transmission line construction; to the detriment of ratepayers and the public.<sup>7</sup> Expediting the study also remains critical to mitigate or avoid the worst climate change impacts.

Third, PCF recommends that the Board clarify that the "report back to the Board in 180 days on the progress of the study"<sup>8</sup> shall be made to the Board at a Board of Supervisor's meeting, as opposed to in a memorandum or any other form that does not involve public notice and participation.

Adequately accounting for the greenhouse gas emissions reduction potential and other benefits of rooftop and parking lot solar, and the high costs of developing transmission lines needed for using power generated from remote, utility-scale renewable energy projects – will allow the County to ensure that its plan for the region reduces greenhouse gas emissions as quickly as possible and to the extent possible, will benefit communities of concern, and will provide maximum mitigation of adverse environmental impacts including climate change, land use, and human health impacts.
