RESOLUTION OF INTENTION TO ORDER IMPROVEMENTS FOR THE SAN DIEGO COUNTY STREET LIGHTING DISTRICT

WHEREAS, the Board of Supervisors of the County of San Diego did, on September 30, 1987, order the formation of the San Diego County Street Lighting District (hereinafter called District), effective July 1, 1988; and

WHEREAS, the District intends to provide for the operation and maintenance of public street lighting facilities in the unincorporated area of the County during the Fiscal Year 2023-24; and

WHEREAS, the Director of Public Works, acting as the Engineer of the District, has prepared and filed an Engineer's Report with the Clerk of the Board of Supervisors (hereinafter called Clerk) in accordance with Article 4 (commencing with Section 22620), Part 2, Division 15 of the Streets and Highways Code.

NOW THEREFORE IT IS RESOLVED, ORDERED, AND DETERMINED that

- 1. The Board of Supervisors accepts and approves the Engineer's Report as modified by said Board.
- 2. The Board of Supervisors intends to levy and collect assessments within the District during the Fiscal Year 2023-24, which represents no increase over the previous year and which does not exceed the maximum voter-approved rate.
- 3. The improvements shall consist of operating and maintaining the public street lighting system located within Zone A of the District as described in the Engineer's Report on file with the Clerk.
- 4. On Wednesday, June 28, 2023 at 9 a.m., in Room 310, County Administration Center, 1600 Pacific Highway, San Diego, California, the Board of Supervisors will hold a public hearing on the proposed assessment.
- 5. The Clerk of the Board of Supervisors is directed to give notice of the hearing in accordance with Section 22626(a) of the Streets and Highways Code at least ten (10) days prior to the date of the hearing specified herein.
