# RECOMMENDATION(S) CHAIR NATHAN FLETCHER

- 1. Allocate \$5,000 from the Neighborhood Reinvestment Program budget (Org 15665), Other Charges, to the County of San Diego Department of Parks and Recreation to sponsor the San Diego Nights Chess Tournament
- 2. Transfer appropriations of \$5,000 from the Neighborhood Reinvestment Program budget (Org 15665), Other Charges, to the County Department of Parks and Recreation to sponsor the San Diego Nights Chess Tournament.
- 3. Find that the grant award described above has a public purpose.
- 4. Authorize the Deputy Chief Administrative Officer/Chief Financial Officer to execute a grant agreement or amendments to the existing agreement with the organization awarded Neighborhood Reinvestment Program funds, establishing terms for receipt of the funds described above, and to make minor amendments to the agreement that are consistent with the general purpose of the grant but do not increase the grant.

## **EQUITY IMPACT STATEMENT**

We recognize that the systemic impacts that inequitable policies may create for residents in San Diego County. The proposed allocation of funds is intended to improve the quality of life throughout the County by providing funds to a nonprofit whose work addresses inequities by providing services to all throughout the county. Organizations are chosen for funding based on

Supporting documents were reviewed as well as impact reports and community testimony to verify the organization meets these goals.

## **FISCAL IMPACT**

The fiscal impact of these recommendations is <u>\$5,000</u> from the Neighborhood Reinvestment Program budget (Org 15665). Funds for these requests are included in the Fiscal Year 2020-21 Operational Plan for the Neighborhood Reinvestment Program (Org 15665). The funding source is General Purpose Revenue. These actions will not result in the addition of staff years or other costs.
