RESOLUTION RELATING TO THE ESTABLISHMENT  
OF HONARARY BRIDGE NAMES IN  
SAN DIEGO COUNTY

WHEREAS, this Board by Board Policy F-53 established criteria and procedures to guide the honorary naming of bridges within the Department of Public Works (DPW) County Maintained Roads; and

WHEREAS, the bridge over the Escondido Creek is included within the Federal National Bridge Inventory and meets the criteria for bridge naming established by Board Policy F-53; and

WHEREAS, a petition signed by at least 100 residents from the community requesting that the bridge over Escondido Creek be named in memory of Sandy Puccio was received by the County; and

WHEREAS, Sandy Puccio became a valued and respected member of the Valley Center Community where she lived; and

WHEREAS, the Valley Center Community Planning Group at a meeting held on July 12, 2021, reviewed and recommended that the bridge be named after Sandy Puccio; and

WHEREAS, the Board of Supervisors of the County of San Diego wishes that the bridge be named after Sandy Puccio and that the Department of Public Works install and maintain honorary bridge naming signage in accordance with Board Policy F-53.

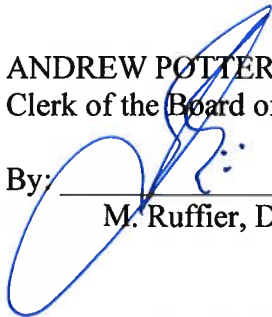
