Section 6. Section 6.1.1 of the Compensation Ordinance is hereby amended as follows:

SECTION 6.1.1: AUTHORIZED POSITIONS: The total number of legally authorized positions in the County of San Diego shall be ~~20~~20,000 regular positions and 5,500 temporary positions. Authorized positions shall only be available for use when they meet the “active” criteria cited in Section 6.1.3.
