NOTICE OF PUBLIC HEARING FOR PROPOSED AMENDED AND RESTATED DISPOSITION AND DEVELOPMENT AGREEMENT BY AND BETWEEN THE COUNTY OF SAN DIEGO AND CHELSEA INVESTMENT CORPORATION OR ITS AFFILIATE FOR LEASE AND DEVELOPMENT OF THE REAL PROPERTY LOCATED AT 5255 MT. ETNA DRIVE IN THE CITY OF SAN DIEGO

On Tuesday, August 31, 2021, the County of San Diego Board of Supervisors will hold a public hearing at 9:00 a.m. to consider adoption of an ordinance authorizing an Amended and Restated Disposition and Development Agreement by and between County of San Diego and Chelsea Investment Corporation relating to the development and lease of the former Regional Crime Lab site consisting of approximately 4.09 acres located at 5255 Mt. Etna Drive in the City of San Diego, California, and further identified as County Assessor's Parcel Number ("APN") 361-661-12 for purposes of affordable housing development.

The proposed ordinance will be presented to the Board of Supervisors at a public hearing on August 31, 2021, at which time public testimony will be received. The Board meets at 9:00 a.m. in Room 310 of the County Administration Center, 1600 Pacific Highway, San Diego, California.

NOTICE OF PUBLIC HEARING AND SUMMARY OF PROPOSED ORDINANCE

Notice is hereby given that the Board of Supervisors of the County of San Diego will consider for adoption an ordinance authorizing an amendment to the Disposition and Development Agreement ("DDA") by and between County of San Diego and Chelsea Investment Corporation or its affiliate for 99-year lease and development of the real property located at 5255 Mt. Etna Drive in the city of San Diego, which is the former Sheriff's Regional Crime Lab site, consisting of approximately 4.09 acres and further identified as County Assessor's Parcels ("APN") 361-661-12, for purposes of developing and operating an affordable housing development and making related findings and authorizations. The proposed amendment to the DDA provides for changes in the financing structure of the DDA and ground lease, adjustments to parking requirements, and the phasing of the project in connection with the affordable housing development.

The proposed ordinance will be presented to the Board of Supervisors at a public hearing on August 31, 2021, at which time public testimony will be received. The Board meets at 9:00 a.m. in Room 310 of the County Administration Center, 1600 Pacific Highway, San Diego, California. Under Executive Order N-29-20, dated March 17, 2020, relating to the convening of public meetings in response to the COVID-19 pandemic, in person participation in this public hearing may not be allowed.
