Section 6. Section 6.1.1 of the Compensation Ordinance is hereby amended as follows:

SECTION 6.1.1: <u>AUTHORIZED POSITIONS</u>: The total number of legally authorized positions in the County of San Diego shall be 22,000 regular positions and 5,500 temporary positions. Authorized positions shall only be available for use when they meet the "active" criteria cited in Section 6.1.3.

Section 7. Effective Date. Section 3 of this ordinance affects compensation and shall take effect upon adoption and all other sections of this ordinance shall take effect thirty (30) days after its adoption. Within fifteen days after the date of adoption of this ordinance, a summary shall be published once with the name of those members voting for and against the same in the newspaper of general circulation published in the County of San Diego.
